


BROOKS ROAD ENVIRONMENTAL NOTICE OF COMPLETION

Environmental Screening Study for the Brooks Road Landfill Amendment to the Annual Fill Rate

Brooks Road Environmental (BRE), owners and operators of the Brooks Road Landfill, have completed an Environmental Screening Study for the proposed Environmental Compliance Approval (ECA) amendment to the annual fill rate of the landfill. The landfill is currently approved to receive up to 1,000 tonnes per day and 151,000 tonnes per year of post-diversion solid non-hazardous Industrial, Commercial & Institutional (IC&I) waste. The amendment would allow for receipt of this maximum daily quantity (1,000 tonnes per day) throughout the year, allowing for an annual fill rate of 250,000 tonnes per year. This change to the annual fill rate will allow for BRE to capture additional wastes generated by their customers.

If the ECA amendment is approved, the landfill will start receiving the maximum annual tonnage starting in 2021. The approval may result in the Site reaching the approved capacity earlier. There is no change to the currently approved landfill volume, footprint, or final contours.



The Environmental Screening Process

The Screening was conducted in accordance with the planning and design process outlined in Ontario Ministry of the Environment, Conservation and Parks' "*Guide to Environmental Assessment Requirements for Waste Management Projects*" dated March 2007.

The Screening process involved identifying and applying screening criteria to determine and describe potential environmental effects, public/external agency consultation, and the development of measures to mitigate identified environmental effects. The results of the Study were documented in an Environmental Screening Report, which is being made available for a 60-calendar day review period starting on April 15, 2021 and ending on June 15, 2021. The Environmental Screening Report is available for public review at www.brenvironmental.com.
